

USB Drive Course Policies & Procedures

A \$50 Administration Fee applies to all enrollments.

Purchasing USB Drive CPA Review Courses

Students can purchase the USB course on the website. The student chooses which part(s) they will sign up for, and makes an A. Deposit. or B. Full payment. If choosing option A, the student is locking in the current price forever. When the student is ready to begin their course, they would [Contact The Office](#) to complete the order. If choosing option B, the student must first complete the registration process. The books and USB Drive will be mailed and the student will receive an e-mail confirmation containing a username, password, and instructions.

Course Duration

The USB External Drive Course expires one year after installation. The USB External Drive Course may be installed on up to 2 computers (i.e. desktop/laptop) by request. You may have unlimited viewings for one year, but in order to prevent fraud or abuse, you must request additional viewings after 10 plays of any individual lecture.

Candidates who purchase a full course on USB drive may choose to purchase an extension. Students may purchase a 1 time 6 month extension (**at the time of purchase only**) for an additional fee. Extensions **must be purchased during original order and cannot be added retroactively**. Extensions can only be purchased with full course USB purchase and extend the course for an additional 6 months. Students who add the extension to their purchase will have 18 months of viewing following the installation of their course, after which the course will expire.

Recycle Program

In order to receive the \$100 deposit return, the USB drive course must be returned within 30 days from the completion of your viewing time-period, with original packaging and accessories, undamaged, and in good working and resalable condition. Please note the drive is delicate and can be damaged in transit if not packaged appropriately. If you are enrolling in a course via a direct bill relationship with your firm, you will not be charged the deposit, thus no refund will be given. After your course expires, you may either return the drive to be recycled or keep it to store important files on.

USB Drive and Other Products Refund Policy

There are no refunds for software, videos, CD-ROMs, books, USB drive, etc. Items may be exchanged for items of the same, or similar value if, returned (in saleable condition) within 7 days of receipt. A restocking fee may be assessed. Postage is to be paid by customer.

In the event that there is a defect in the item ordered or if it arrives damaged to the customer we will replace the item free of cost. **NO RETURNS or EXCHANGES FOR ORDERS SHIPPED OUTSIDE THE UNITED STATES.** There are no returns, refunds or cancellations on the USB drive course.
